WHEREAS the settler is desirous of the establishing a trust for all public objects as appended herein below to be carried out anywhere in India and / or Abroad.

ANDWHEREAS the Trustees have, at the request of the settler, agreed to act as the first trustees along with and including the SETTLOR himself as one of the trustees for administering the affairs of the trust in accordance with the terms and condition hereinafter provided.

ANDWHEREAS it is necessary to declare the objects and terms of the public charitable and religious trust, being constituted under these presents.

Now this indenture witness as follows :-

1. That, in order to effectuate his aforesaid desire, the settler has set apart and handed over to the trustee a sum of Rs. 3,00,000/-) Three Lakh Only, hereinafter called the ' Corpus Fund') and, the trustee shall hold and stand possess of the same upon the trust subject to the powers, provisions, declarations hereinafter contains.

That the name of the trust shall be "**Kharagpur College Alumni Association** " hereinafter referred to as "Trust" and its office shall, for the present, be situated at **Kharagpur College Alumni Association** .Kharagpur College Post-Inda. Kharagpur. District .Paschim Midnapur.

- a) and/or at such other place or places as the trustees may decide from time to time.

2. That the objects for which this trust is established are :-

- a) To establish, develop, maintain, run, grant aid in cash or in kind to, School College, boys and girls, hostel, boarding house, nursing institution dispensaries maternity homes, khadi & village industries, cottage industries, child welfare centres to rehabilitate arrange and organize various child welfare programmes, Health Awareness Programmes and/or such other similar charitable institution in India or abroad for the benefit and use of the general public.
- b) Auto CAD Training (Civil ,Mechanical , Archit ,AutoCAD Map 3D Training ,GIS Software Training. CT,CTT ,Training ,Basic Computer Corse ,Tally, remote sensing Software .Hardware .Mobile Training, Project Work. Etc)
- b) To establish run, support and grant aid or other financial assistance to school, College, day care centres, college, liabraries, reading rooms open school of distance education, universities, laboratories research and other institutions of the like nature in India and abroad for the development and advertisement of education and diddusion of knowledge amongst the public in general.
- c) To promote, establish, support, maintain or grant aid to institutions for the promotion of science and technology, infornation technology, animal husbandry, herbal plants, bee keeping, pisci culture aforestation, watershed Development, waste land development, agriculture, natural resources (ANR) etc.
- d) To provide skill development training to rural people for their self employment in the field of food processing, mushroom cultivate and spawn production, bamboo craft, random rubble block, poultry, forestry, dairy farming, flsheries, bee-keeping, piggery etc.
- e) To promote, establish, support, maintain or grant aid to institutions for Rural development, Science, Literature, Music, drama and fine arts for the research and development for the benefit for the public in general, to promote self help group, micro finance and micro credit, income generation activity etc. for the livelihood and improvement of Schedule Tribes Schedule Caste, people of slum areas and other weaker section of the society.





- f) The established run maintain and/or grant aid to old-age-homes for the aged, orphanages for orphans, child care homes, remand home for children or other establishment for the relief and help to the poor, needy and destitute people, orphans, widows, children, S.T. S.C & O.B.C and aged persons of the society.
- g) To establish and develop institutions for the physically handicapped and disabled or mentally retarded person and to provide them education, food, clothing and other help.
- h) To grant relief and assistance to the needy victims during natural calamities such as feminine, earthquake, flood, fire etc.
- i) To establish, run support and maintain drug de addition centre (S), leprosy eradication centre (s). Tuberculosis sanatorium, village Health centre, adult education centre (s), Social education centre (s), AIDS/HIV prevention and awareness centre (s) family centre, hostel for girls student and working woman, training and development centre for human Resource development, provide all necessary help in the event of any epidemic and all its manifestations. Blood Donation camp.
- j) To publish and self books, forms illustration, magazines, journals, periodical, souvenirs, cassettes, compact discs, brochures etc to fulfill the objectives of the Trust.
- k) To help aid, assist, promote, sponsor, develop, formulate, organize maintain and carryout integrated development programmed in the field of education, environment, healthcare, sanitation, family welfare etc.
- l) To rejuvenate rural economy by inviting participation of women in economic activity.
- m) To promote, provide self-employment among SC/ST backward classes and other weaker section of the society through various schemes of Government and other agencies & preserve integrated rural development programme, natural resource, income generation activities of rural people in all field.
- n) To establish maintain, run support church-planting, chapels, biblical training centres, evangelize the world, assemblies/ congregations, institutions and development as may be necessary for the propagation of the gospel and the edification of believers.
- o) To provide, carryout medical research and development of all field of medical science.
- p) To found, establish or takeover and/or otherwise conduct research institutions of medical and surgical knowledge.
- 3) That are trust fund may be augmented by the income from the initial fund and also by and other contributions from any person (s), Government companies (s), institution (s) and also from national and International funding agencies time to time.
- 4) That the trustee (s) shall always maintain proper accounts of the trust, which shall be kept at the office of the trust.
- 5) That for the furtherance of the objects of the trust, the trustees (s) shall have the following powers.
- a) To apply to and accept any donation, contribution, grant, aid or subscription in case or in kind, from any person (s) the Government public bodies, urban, local, municipal, district, companies, body or persons or trust, national and international funding agencies with or without conditions.
- b) To apply the whole or any part of the income of the trust or the trustfund or accumulations thereto, to any one or more of the objects of the trust, as the trustees may in their discretion, deem fit from time to time.
- c) To convert and deal with the trust property and/or any investments for the time being.
- d) To invest the trust fund either in the purpose of mortgage of immovable property or in shares, stock or debentures or other securities and investments, or in deposit with or loans to any company, bank, firm or any other person, and to alter, vary or transpose such investments from time to time at the discretion of the trustees.
- e) To borrow or raise or secure payments of moneys and also to lend money either with or without security.
- f) To sell, dispose of, alienate or otherwise deal with any property comprising the trust fund.
- g) To let out, demise any immovable property comprise in the trust fund for such period and at such rent on such terms and conditions as the trustees in their discretion may think fit.
- h) To purchases/acquire land & building/structure etc. in the name of trust.





- i) To open account (s) in the name of trust with any nationalized bank or banks and the bank account shall be operated jointly by the Secretary and the Treasurer of the trust.
 - j) To adjust, settle, compromise, compound, refer to arbitration, all action, suits, claim, demands and proceeding regarding the trust fund.
 - k) To appoint constituted attorneys or agents and to delegate to such attorney or agents all of any of the powers vested on them under these presents and from time to time remove such attorneys or agents and to appoint others in his or their place.
 - l) To take over or amalgamate with any charitable trust, society, association or institution with similar objects.
 - m) To make, vary, alter or modify schemes, rules & regulation for carrying out the objects of the trust and for the management of the affairs thereof and/or running any institution in the furtherance of the object of the trust and otherwise for giving effect to the objects of the trust.
 - n) To set apart and/or allocate the whole or a part of the income or the corpus of the trust Fund or part thereof for any of the objects of the trust.
 - o) To purchase or otherwise acquire and undertake all or any part of the property, assets, liabilities and engagement of any or more of the trusts, societies and institutions having object (s) similar to it.
- 6) The trustees shall be accountable only for such money, stocks, share and funds as shall actually come into their hands and a Trustee shall not be answerable or accountable for neglect, default, acts or omission or commission of the other trustees nor of any banker or other person with whom the trust properties or any securities may have been deposited invested or kept.
 - 7) The trustee are not entitled to receive any remuneration, but the trustees may reimburse themselves all expenses actually incurred by them in connection with the trust or the duties relating thereto.
 - 8) The number of the trustees shall not be less than three and more than nine.
 - 9) Duties of the trustees :- All and every trustee of the trust shall.
 - a) Elect the Managing Trustee/Governing Body of the Trust.
 - b) Attend the General Body meeting regularly.
 - c) Give me necessary information to the Trustee, performing to any matter which is necessary to be known by the trust.
 - d) Not indulge in activities which are prejudicial to the interest and object and/or the Rules & Regulation of the trust.
 - 10) General Body All the members of the trust will constitute the General Body of the Trust.
 - 11) Managing Trustees/ Governing Body.
 - a) Strength:- The strength of Managing Trustee/ Governing body(including office bearers and Executive member) shall not be less than 4 and more then 7.
 - b) Term:- Term of every governing body shall be three years.
 - c) Notice:- Minimum 7 days notice shall be required for every governing body meeting of the trust but urgent Governing body meeting can be called by 24 hours notice.
 - d) Quorum:- Quorum of every Governing Body meeting and also in urgent Governing Body meeting shall be 2/3rd of the total strength of the Governing body.
 - e) Meeting: - Governing Body meeting shall be held once in every year regularly or as and when the Governing Body of the trust may decided from time to time.
 - 12) Function & Power of Governing Body
 - a) Governing Body shall be responsible for the management and administration of all affairs of the trust and is also authorized to appoint any office bearer, executive member to look after any particular activity.
 - b) All decisions shall be taken by the majority votes.
 - 13) Composition of the Governing Body: -
 - A. President B. Vice- President
 - 14) C Secretary D. Asst- Secretary. E. Treasurer and rest are Executive Members.

15) Powers and Duties of Office Bearers: -

A. President:-

- i. To preside over all meeting of the trust.
- ii. All the time of voting on any matter/ subject (except election), if the total votes of the groups of members happen to be equal in number, the president has the power to cast an extra vote to decide the matter/ subject.
- iii. Shall issue instruction to all members and guide them for efficient works.

B. Secretary: -

- i. The secretary shall be executive head of the trust and shall without prejudice to his other administrative right and obligations be empowered.
- ii. Shall be the over all in-charge of the affairs of the trust property and he shall control, supervise and guide the working of the trust.
- iii. Secretary shall raise, collect and receive subscriptions, gifts, donations or legacies for the object of the trust,
- iv. Secretary will summon and attend the meetings of the Governing Body and General Body.
- v. Secretary will prepare the membership register as well as the proceeding register to record the minutes of the proceeding of the Governing Body meeting and the General Body meetings and have them duly signed by the members who attend the meeting.
- vi. All suits, actions and proceedings by or against the Trust may be institution or defended in the name of the secretary for the time being or such other person (s) as may be appointed by the governing body of the trust.
- vii. All expenses of the trust including the expenses of any branch that may be established shall be met by the Secretary out of such fund of the trust.
- viii. The secretary shall be entitled to do such acts or things as may be necessary for the Management of the affairs of the trust.

C. Treasurer:-

- i. All funds of trust shall remain under the care and management of treasurer.
- ii. Treasurer shall maintain the accounts of all money which is received and/or paid by him/her on behalf of the trust.

15. The managing Trustees/Governing Body for the time being consists of the following members including the SETTLOR. (Including office Bearers and executive members).

16. The managing trustees/ Governing body can hire services of the professional, consultants, doctors, legal advisors and/or of other person (s) in their respective fields for achievement of the objectives of the trust and/or also in case of any dispute or differences arises amongst the trustees.

17. The managing trustees/ Governing body for the time being will be at liberty to appoint additional trustee (s) within the number mentioned above the such period or on such terms as to retirement and reappointment as the trustees for the time being considered proper a person shall cease to be a trustee either : (I) if he without leave of absence does not attend there consecutive meeting of the trustees or for on calendar year, which ever is longer, or (ii) if he is requested to resign by 3/4th or as near thereto as possible of the remaining trustees.

18. Every trustee will be at liberty to resign on giving one month notice of his intention to do so.

19. The trustees may have time-to-time frame rules for the conduct and regulation of the meetings of trustees. In the absence of such regulations.

a) Five trustees shall form a quorum for a meeting of the trustees.

b) All matters will be decided mutually by the trustees.

20) Resolution passed without any meeting of the trustees but by circulation there of and evidenced in writing under the hands of 2/3rd of the trustees shall be as valid and effectual as a resolution duly passed at a meeting of trustees.


21) The Trustees shall have the power to determine in case of doubt whether any money or property shall for the purpose of charity be considered as capital or income and whether out of income or capital any expenses or outgoings ought to be paid or borne and every such determination shall binding and conclusive provided that nothing contained shall be deemed to authorize the trustees to spend the income or corpus of the trust for any purpose and authorized by these presents.


22) The accounting year of the trust shall be financial year ending on 31 march every year.

23) The trust and the trust funds shall be an irrevocable for all time.

In the event of dissolution of the Trust, the entire Trust funds shall be realized and first be used for payment of liabilities of the Trust. The assets left if any, shall be disbursed and distributed to the Board of Trustees or their relatives or related concerns.
