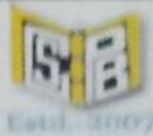

### **Scope, Goals and Forms of Cooperation**

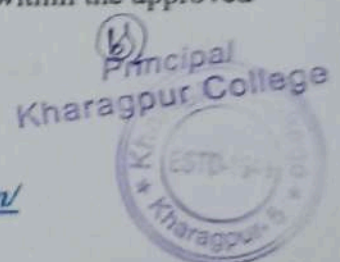
The signing institutes agree to provide opportunity as appropriate for the following activities towards the completion of the objectives of this MOU:

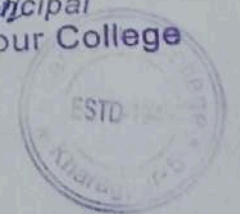
### **Reporting**

### **Implementation of the Memorandum of Understanding**

- I. It is understood that the First party and Second party subscribe to the principle of equal opportunity and do not discriminate on the basis of state, race, sex, age, cast or religion. Both the institutions shall abide by these principles in the administration of this agreement and neither party shall impose criteria for exchange of scholars or students, which violate principles of non discrimination.
- II. Student and research scholars may visit the corresponding departments of the institute after finalizing a mutually acceptable schedule.
- III. Any event, joint program, joint research activities, or similar activities, undertaken under this MoU will have no financial commitment on either institution and that will be decided separately for each event.
- IV. All the expenses shall be the direct responsibility of the student concerned (subject to any agreements on payment arrangements made by either institution with its own students).
- V. The researchers will be allowed to make use of the instruments and other research facilities available in various departments of these institutes after prior approval of the visiting schedule and due approval from Heads of both Institutions.
- VI. Both parties promote research and realize collaborative projects giving priority to interdisciplinary works.

### **Terms and Conditions**

1. This MOU shall become effective from the date it is signed by the parties and shall be valid for three years. In case both parties would like to extend the partnership to five years the amendment papers should be made and signed by the authority of both sides and shall be regarded as a part of this MoU. This MOU may be amended by mutual written agreement and may be terminated at any time by either party upon written notification signed by the competent authority of the party initiating termination. Such notification must be given to the other party at least six months in advance from the effective date of termination.
