### MEMORANDUM OF UNDERSTANDING

BETWEEN

AND

GOVT. GENERAL DEGREE COLLEGE, LALGARH (GGDC, Lalgah), a reputed academic higher education institution, located at Binpur-I, Lalgah, P.O: Lalgah, Dist: Jhargram (W.B.) INDIA, PIN-721516 as the **SECOND PARTY**.

Both the parties herein have noted the importance of the value of cooperation and have agreed to enter into this Memorandum of Understanding (MoU) regarding academic collaboration. The purpose of this non-binding MoU is to make possible academic, research, extension and cultural exchange between both the parties based on the principles of mutual equality, understanding and the reciprocity of mutual benefits. NOW THIS MEMORANDUM OF UNDERSTANDING is agreed by and between both the colleges hereto as follows:

#### Objectives, Scope and Major Activities:

Both institutions agree to encourage the development of the following types of activities:

- Formal exchange of faculty members in specific mutually agreed upon areas of education, research and outreach in connection with the prior permission taken from Higher Education Department, Govt. of W.B. if required.
- Cooperate in under-graduate/ Post graduate education and training and knowledge transfer through library as well as laboratory resources.
- Organize joint conferences, seminar, webinar, symposia, or other meetings on subjects of mutual interest time to time.
- Exchange of academic information and materials following NEP 2020 guidelines.
- Pursue avenues for student exchange during the academic year.
- Explore the possibilities for developing joint research programs and collaborations.
- To develop life skills, hire the resource persons on voluntary basis for students' programme/ projects under the NEP 2020 syllabus. It means teachers and students will explore field possibilities at different places in W.B. with specific purpose to enrich their knowledge in addition to extension activities.
- To arrange invited talk, students' motivation work, modelling, youth science fair, poster making, PPT presentation and micro level swachhata and sustainability programme related works after proper planning.
- Field trips, nature trails and some research work in which teachers and students both may participate and help to the programme organizers (Govt./ Non-Govt.) to develop community work if required time to time.
- To develop scientific temperament through motivated programmes like Biodiversity study, sky watching, natura trail, scientific writing and skill adopted programmes if required.

### Responsibilities of the Institutions:

The two institutions identify that the execution of any agreed upon activity will depend upon the interests and expertise of the individuals involved and the availability of financial resources, space and other resources. Accordingly, the functioning of any exchanges or collaborative programs based on this MoU shall be conferred and determined between the two institutions. It is further expected that both the institutions will be compliant with all applicable legislations of Government of India and State and University policies.

### Duration and Option to Amend, Extend or Terminate:

This MoU will become effective when signed by authorities of both institutions. The agreement will remain in effect for **5 (five) years** from the date of signature given below, and may be renewed or amended by mutual agreement of the institutions. The institutions should agree to periodically review the activities undertaken and the progress made and to consult concerning amendments, renewal or termination of this MoU. Either authority may terminate this MoU at any time by providing written notice prior to three months before such termination to the other authority.

### General Terms:

This MoU is not intended to, and does not create any right, benefit, or trust responsibility, substantive or procedural, enforceable by law or equity, by either party, its officers, employees, or agents against the other party, its officers, employees, or agents. Nothing in this MoU obligates either party to commit or transfer any funds, assets, or other resources in support of projects or activities between the two parties. Neither party will use the name of the other, either expressly or by implication, in any publicity, solicitation or advertisement without the express written approval of the other party to this MoU.

### 5. Signatures:

This MoU is valid for 5 years and shall enter into force on the date of the signing by qualified representatives of both institutions.
