Scope of the MOU:

The basic objective of this MOU is to promote academic exchange in terms of exchange of faculty and academic association between the departments of English, History & Philosophy of the two colleges, to enrich academic exchange where the faculty members of the departments of English, History & Philosophy from Kharagpur College and Debra Thana Sahid Kshudiram Smriti Mahavidyalaya, will be involved in resource sharing and academic associations like organizing seminars, webinars, workshops, special classes etc. As per the consent of both the institutions the Post Graduate students in English of Debra Thana Sahid Kshudiram Smriti Mahavidyalaya have been studying their CBCS course in the Post Graduate Department of History of Kharagpur College since the session 2019-2020 till date. The said practice be maintained and encompassed under the periphery of the current MOU. Moreover during the coming academic sessions both the institutions agree to



exchange their students for studying certain courses (paper) that might be taught in one of the intuitions while some other course (paper) in the other one.

Objectives:

- 1. Faculty exchange for special lectures, workshop, seminars, and academic exercise.
- 2. Sharing of resources by faculty members of the concerned departments of the two colleges with prior authorization of the H.O.Ds of the concerned departments.
- 3. Students and teachers may visit and use libraries of both the colleges.
- 4. All such activities will be done as per the existing guidelines of the university, State Government and UGC

General Terms and Conditions

- 1. Duration of MOU: This MOU will be effective from the date of agreement and will have an initial duration of three years. The MOU may be extended with the consent of both the parties.
- 2. Engagement of department level co-ordinator: The colleges will empower an appropriate faculty to co-ordinate the implementation of activities.
- **3. Confidentiality:** Both the colleges will maintain confidentiality about the terms and conditions of the agreement.
- **4. Termination of MOU:** This MOU may be terminated at any time with a 15 day prior notice from either party.
- **5. Modification:** Any alteration /modification to the MOU may be done with mutual consent of both the parties. Involvement of new departments / activities may be done from time to time with mutual consent of both the colleges.
