1. Objective

Both the institution and the organization will work together to enhance and upgrade the journal as per UGC guideline.

- 2. To collaborate and cooperate with each other in smooth publication of the journal.
- 3. To work jointly for common interest in regard to publication of the INQUEST journal.
- **4.** To encourage any other activities that both the institutions agree to be of mutual interests/benefits.
- 5. Publications, if any, in respect of the activities covered under this MOU shall be in the names of involved personnel from both the parties. In all publications (papers, reports, etc.) it will be duly acknowledged that the work has been carried out by Kharagpur College and KSERA.
- 6. All ethical guidelines of research publications existent at both the institutions will be followed strictly.

7. Coordination

In order to carry out and fulfill the aims of the agreement, each institution will empower an appropriate body of members to coordinate implementation of activities. The concerned members will meet regularly to discuss the plan implementation and progress of the activities.

7. (a) An appropriate body will be formed from both of the parties for the functioning of the journal. A body of associate editors with sixteen members will assist the joint editors from both of the parties.

8. Financial Commitment.

This MOU. being a cooperative and collaborative understanding for publication of the journal will bear the expenditure jointly by mutual understanding, but shall not create any legal and/or financial commitment what so ever on either of the parties hereto, except as may be provided in activities specific agreement that may be entered into subsequently.

9. Implementation and monitoring

A steering committee will monitor the progress of the collaborative activities under the MOU on a quarterly basis and compliance of the terms and conditions specified thereof.

10. Term and Termination.

The memorandum of understanding will be in-force for a period of two years from the date of signing of the same and thereafter may be renewed for further period of two years subject to such other terms and conditions as may be mutually agreed upon.

11. Notice

All notices and other communications required to be served under terms of the MOU shall be considered to be duly served if the same is delivered by e-mail and other mailing systems.

12. Intellectual Property Rights (IPR) protection

IPR generated during the activities under the MOU shall be in possession of Inquest journal. The extent of ownership shall be decided mutually depending upon the relative level of intellectual levels made by the parties.

The terms and provisions in this MOU.also apply to any subsequent Addendum to this agreement. The parties executed this MOU on 17. 14. 91 2023 and remain valid up to two years.
