MEMORANDUM OF UNDERSTANDING

Both the parties herein have noted the importance the cooperation and have agreed to enter into this Memorandum of Understanding (MoU) regarding the development of Physical Fitness and Self-defense skill among the students of the College. 1. Objectives, Scope and Activities

2. Responsibilities of the Institutions

The two institutions identify that the execution of any agreed upon activity will depend upon the interests and expertise of the individuals involved and the availability of financial resources,

space and other resources. It is further expected that both the institutions will be compliant with all applicable legislations of Government of India and State and University policies.

3. Duration and Option to Amend, Extend or Terminate

This MoU will become effective when signed by authorities of both institutions. The agreement will remain in effect for five years from the date of signature given below, and may be renewed or amended by mutual agreement of the institutions. The institutions should agree to periodically review the activities undertaken and the progress made and to consult concerning amendments, renewal or termination of this MoU. Either authority may terminate this MoU at any time by providing written notice prior to three months before such termination to the other authority.

4. General Terms

This MoU is not intended to, and does not create any right, benefit, or trust responsibility, substantive or procedural, enforceable by law or equity, by either party, its officers, employees, or agents against the other party, its officers, employees, or agents. Nothing in this MoU obligates either party to commit or transfer any funds, assets, or other resources in support of projects or activities between the two parties. Neither party will use the name of the other, either expressly or by implication, in any publicity, solicitation or advertisement without the written approval of the other party to this MoU. In these span of 5 years no other Martial Art Institution/Academy and any other Martial Art Coach or Self Defense Instructor will not be allowed/given permission by Kharagpur College to conduct any Martial Art or Self Defense event/Camp or Seminar.

5. Signatures

This MoU shall enter into force on the date of the signing by qualified representatives of both institutions.


