# MEMORANDUM OF UNDERSTANDING (MOU)

### MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (hereinafter 'MOU') is entered into on this DAY, that is, 9th February, 2023 (09.02.2023) by and between

Kharagpur College, Inda, Kharagpur Paschim Medinipur, 721101, West Bengal, India THE FIRST PARTY, represented herein by its Principal, Dr. Bidyut Samanta

AND

Government General Degree College, Dantan-II, Kashmuli, Porolda, Dantan-II, Paschim Medinipur, West Bengal, Officer-in Charge Dr Shaishab Kumar Dinda.

#### PURPOSE OF MOU

### In particular, this MOU is intended to

- 1. Exchange faculty for organizing seminars/symposia/conferences in collaboration as and when required;
- 2. To offer Add-on course(s), as would be decided by both parties, on blended mode(offline and online) for students of both institutes and to develop content/module for the same jointly;
- 3. To exchange students of both institutes for add-on/certificate courses/special classes;
- 4. To organize joint teaching and research projects;
- 5. To organize social/cultural/sports activities on blended mode or offline; and, online;
- 6. Any other academic activity that would be mutually agreed upon and is beneficial to both the parties

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN TH IS MOU, THE PARTIES HERE TO AGREE AS FOLLOWS:

# Clause 1 OBJECTIVES SCOPE OF THE MOU

- 1. A. As both parties are united by common interests and objectives, they should make arrangements for organizing state-level/national/international seminars, conferences or symposia by academic departments or IQACs of both the parties. In such cases the expenditure would be borne by the host Party.
- 1. B. Both the parties, being located in the rural areas, would offer vocational/add-on courses on blended mode (offline and online). Academic departments of both the parties would jointly develop contents/modules of such add-on/vocational courses.
- 1. C. The co-operation between First Party and Second Party will facilitate effective utilization of the intellectual capabilities of both the parties, especially in developing new teaching systems and research facilities.
- 1. D. Both the parties, keeping in mind, organize online cultural events/competitions for students of both colleges.
- 1. E. IQACs of both parties would sit once in two months to decide upon the modalities of the present MOU and to suggest improvisations on it.
- 1. F. If any Party organize any sporting/cultural/academic event(s), students and accompanying students of the other party may participate in person. In that case, participating students of the any Party would be provided accommodations free of cost in the hostels of the first Party. As for food and other logistical expenditure, the participating party would remain responsible.

## Clause 2 TERM AND EXPIRATION OF THE MOU

- 2. A. It is understood that the this agreement would take effect after being signed by both parties and will remain functional for a period of THREE YEARS from this day, that is, from 09.02.2023 to 08.02.2026. After the expiration of the validity, it would be extended for a period of another three years unless and until any of the Parties expresses in writing any intention to cancel the agreement.
- 2.B. Both Parties may terminate this MOU upon 30calendar days' notice in writing. In the event of termination, both parties have to discharge their obligations as per the conditions of the current agreement.

# Clause 3 NON-EXCLUSIVITY

- 3. A. As this understanding is a non-exclusive agreement, both the parties may into similar/different agreements with other or third parties.
- 3. B. The agreement does NOT make it binding on any of the parties to consult or take permission before entering into any kind of MOU with other or third parties.

# Clause 4 SPECIAL PROVISIONS UNDER THE MOU

4. A. Either party would take prior approval from the other party in writing for using the name and logo for any academic activity mentioned in the clauses above.

4. B. Both parties would keep each other informed of any academic development like seminars/symposia/conferences in writing even when the other party is not directly involved in organizing the said event.

4.C. In case both the parties organize/offer any course/training together, name and logo of the participating institute should be clearly mentioned in the course brochure and

certificates.

#### Clause 5 SETTLING OF DISPUTES

If any dispute(s) arise in respect of this MOU, Principals and IQAC Coordinators of both the colleges would settle the matter amicably.
