1. Objective

field of teaching and research by sharing, and exchanging its faculties and students of UG & PG levels. Specific academic activities under this MOU will be identified through consultation between the departments of Sanskrit of the two colleges. Each college agrees to provide academic and technical assistance to carry out the specific activities which will improve the academic atmosphere, academic activities, extension activities, academic collaboration, academic quality, student's progression, cultural atmosphere, and research atmosphere in the said departments as well as the quality enhancement of both of the colleges by this collaboration and exchange programme.

2. General Terms of MOU

- A. Duration of MOU:** This MOU will be effective from the date of the agreement and will have an initial duration of two years. There is also a provision to extend the MOU.
- B. Coordination:** In order to carry out and fulfil the aims of this agreement, each college will empower an appropriate faculty to coordinate the implementation of activities. The concerned faculties will meet regularly to discuss the plan, implementation and progress of the activities.
- C. Technical and Financial Support:** Technical & financial support for each activity will be provided by the concerned college.
- D. Confidentiality:** At any time, after executing the activities of this MOU each college agrees that none of the colleges will disclose any information in related to these activities without the consent of both colleges.
- E. Termination of MOU:** The partnership covered by this MOU shall be terminated upon the completion of the agreed period

of two years. The agreement may also be terminated with a written one-month notice from both sides.

F. Extension of Agreement: The MOU may be extended according to the willingness of both colleges with prior intimation and permission of the authorities one month before the end of the MOU.

G. Communications: All notices, documents and any other communication under this agreement in connection herewith will be in written form and sent to the postal address, email, or fax of the concerned college. Any notice shall be effective from the date on which it is signed.

H. Addendum: Any Addendum to this MOU will be in written form and signed by authorities of both colleges.

I. Programme Consult: All programmes will be taken by the concerned department of a college with the prior consultation of the corresponding department of another college.

J. Venue of the Programme: Each college will organize any programme on their own premises in collaboration with another college by using their own assistance and resource. Third place may be treated as a venue of any programme by the consultation of the two colleges with the financial sharing.

3. Other Provisions

A. Initially departments of Sanskrit of both colleges will be engaged to conduct the students of UG & PG and faculty exchange programme. This type of exchange programme will be continued for any other departments by the consultation of the authorities of the two colleges.

B. This type of exchange may be implemented in the field of cultural programmes and sports activities.



- C. Students and teachers may visit and use the departmental library as well as the central library.
- D. Students and teachers may use the resources of the college during the exchange and extension activities.
- E. Class teaching may be shared with the students due to prior permission of the authorities with a proper Identity Card.
- F. Faculty exchange for a special lecture, seminar class and other programmes will be made at the departmental level with the consultation of specific faculty and the department.
- G. Both parties assume that this agreement does not go against the rules and regulations of the Government of WB & UGC.

The terms and provisions in this MOU also apply to any subsequent Addendum to this agreement.

The parties executed this MOU on 22nd December 2021 and will remain valid up to two years.
